# PHANTOM DRAGONS / PINK PHANTOMS

## Code of Conduct and Coaches Expectations of the Athletes

As a member of the Phantom Dragons / Pink Phantoms team, I agree to be bound by the following standards of conduct:

- Coaches will treat all participants with due respect and integrity. Athletes shall strive to promote a positive and competitive training environment, and shall provide encouragement and support to everyone on the team. Hazing, bullying, threats, or physical/emotional abuse of any kind will not be tolerated.
- Paddlers of all ages, experience / ability levels, and degrees of motivation and/or commitment are welcome to. Any discrimination based on race, religion, sexual orientation, etc. is strictly prohibited. But please, leave your pets at home.
- Athletes shall treat event officials, other competitors, & their teammates and coaches w/ respect at all time. They will be expected to live and compete with class & integrity, being gracious in victory, and accepting defeat with poise & dignity.
- Team members shall refrain from use of alcohol, drugs, tobacco & vaping at all competitive events. At other team events (post-competition parties, team meetings, etc.) drinking may be acceptable (depending on the nature of the event), provided it is in moderation. Use of recreational drugs, tobacco and/or vaping is not acceptable under any circumstances at activities that are in any way related to, or associated with, the Phantom crews or DRACO.
- Within the framework of each individual athlete's specified level of commitment (as indicated below), he/she will make attendance at all racing and training opportunities a priority, and make every effort to be on time when attending.
- It is understood that practice schedules, notices and other documentation are to be disseminated primarily via EMail. Team members agree to check for team EMail daily, to read all such messages in their entirety, and to RSVP (when appropriate) within a reasonable time after receipt.
- Athletes agree to provide application forms, waivers, surveys, and other team-related documentation promptly upon request (within 2 weeks maximum), and to pay all team, practice and race fees (cases of financial hardship excepted) in a timely manner.
- Team members are expected to comply with practice rules and safety procedures, and follow the coach's and/or team captain's instructions, without exception. Tactful, one-on-one discussions of any concerns, questions or ideas can be handled before or after practice sessions, as appropriate.
- Athletes understand that decisions concerning race team rosters will be made by the coaching staff based on objective selection criteria including fitness testing, OC time trials, and assessment of individual skill/technique, along with a variety of subjective criteria including attendance, a positive/team-oriented attitude, timely submittal of documents & fees, leadership / motivation attributes, etc. Decisions by coaches will be made with honesty, integrity, and fairness to all participants, and will be final. Remember, racing is a privilege - you have to earn it!

- Gold Level** *I expect to generally attend all scheduled practices (3x/week), and miss only in rare cases of sickness or extraordinary circumstances.*

I agree to the following sanctions, in the form of required contributions to the "Naughty Paddler" Jar, for failure to adhere to the specified expectations (proceeds will be used to finance team operations and/or events):

- Failure to RSVP \$5.00
- Failure to Show Up for Practice \$5.00 (when positive RSVP submitted)
- Late for Practice \$5.00 + \$1.00/minute for every minute over 10 minutes late (\$10.00 maximum)
- Failure to Submit Paperwork \$5.00 (if not received within 2 weeks) + \$5.00 per week thereafter
- Failure to Submit Fees 20.0% (if not received within 2 weeks) + 10.0% per week thereafter (except cases of financial hardship)

## Adult Individual Waiver, Release of Liability, & Assumption of Risk

In consideration of being allowed to participate in activities and events of the Phantom Dragons / Pink Phantoms race teams (PD) and/or Dragonboat Racing Association of Colorado (DRACO), the undersigned hereby voluntarily agrees to release, waive, indemnify, hold harmless, and forever discharge and covenant not to sue or make claims against PD and/or DRACO, their board members and organizers, officers, agents, trainers, coaches, sterns, participants, employees, volunteers, sponsoring agencies, advisors, advertisers, the City and County of Denver, the City of Arvada, the City of Wheat Ridge, and any and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "PD/DRACO") from any liability, actions, claims and/or demands on behalf of myself, my heirs, spouse, parents, estate, executors, administrators, assigns, & personal representatives for any loss, injury, damage, or death resulting, directly or indirectly, from my participation in dragon boating and/or other PD/DRACO activities and the use of any related equipment. I further agree as follows:

1. I understand that prior to participation in any PD/DRACO activities, I will inspect the facilities and equipment to be used and, if I believe anything is unsafe, I will notify appropriate PD/DRACO personnel of such condition(s). I also agree not to participate until any such unsafe condition(s) is/are corrected.
2. I acknowledge and fully understand that dragon boating and/or other PD/DRACO activities, some of which are conducted in and around a body or bodies of water, involve inherent risks that could result in serious injury, including permanent disability and death, and/or severe social and economic losses to myself, my property and/or third parties, and that these might result from my actions, inactions, the negligence of others, the rules of play, or the condition of the premises or of any equipment used; and further, that there may be other risks not known to me or reasonably foreseeable at this time.
3. I expressly agree and promise to accept and assume all foreseeable and unforeseeable risks involved in dragon boating and other PD/DRACO activities. My participation in these activities is voluntary, and I elect to participate in the dragon boating and other PD/DRACO activities and fully understand the inherent risks involved. I further agree to assume the risk(s) attributable to any medical or physical condition that I may have.
4. I agree that my participation in dragon boating and/or other PD/DRACO activities will be in accordance with the guidance, instruction and/or rules of PD/DRACO. I assume responsibility for being fully informed of all safety rules and agree that I, and the rest of my team, will abide by all such rules, including wearing a suitable personal flotation device (PFD) whenever I am on the water. I further agree that I will use PD/DRACO dragon boats, paddles, PFDs and any other equipment provided or borrowed from PD/DRACO (or their contractors) at my own risk. I expressly acknowledge and agree that PD/DRACO and its contractors shall not be liable for any injury, loss, damage or death resulting from the use or suitability of any such equipment.
5. I understand that at any PD/DRACO activity, I may be photographed by PD/DRACO. I agree to allow my photo, video or other digital/film likeness and/or reproduction thereof, made through any media, to become the property of PD/DRACO and to be used for any legitimate purpose thereby.
6. I agree that this Waiver, Release of Liability, & Assumption of Risk is governed by the laws of the State of Colorado. If any portion of this Waiver, Release of Liability, & Assumption of Risk is deemed void or unenforceable, the remaining portions shall remain in full force and effect.
